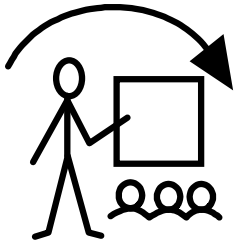
Frances Lee has over twenty five years experience as a social worker and is currently registered with the Care Council for Wales and a member of the British Association of Social Workers.



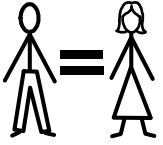
She began her career as a social worker in the learning disability service and has also been a Team Leader on a CTLD in the London Borough of Hounslow.



Prior to working independently she was Learning and Development Officer for learning disability services with Carmarthenshire Council.



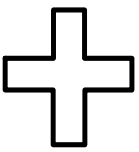
